#### **SUBJECT:** Post adjustment classification memo for May 2020

1. I am pleased to send you the post adjustment multipliers for May 2020. Note that only duty stations with changes in post adjustment multipliers are listed.

### **Group I Duty Stations**

2. The post adjustment multipliers, applicable to group I duty stations, as a result of the operation of the 0.5 per cent rule under conditions of currency depreciation/appreciation relative to the US dollar, with effect from 1 May 2020, are given in Table 1.
